

Triathlon Saskatchewan Club Eligibility Requirements:

Clubs must renew their affiliation with the Triathlon Saskatchewan on an annual basis as either a For-Profit OR Not-For-Profit club. Until the document has been received and approved by Triathlon Saskatchewan, the club and its activities will not be considered sanctioned. Not-For-Profit Clubs are eligible for funding and grants.

- 1. All clubs must submit to Triathlon Saskatchewan a full list of club members including name, address and email annually.
- 2. For-profit versus non-profit status: Triathlon Saskatchewan may approve club status to any group meeting the eligibility requirements listed in this document. This includes clubs deemed as not-for-profit and for-profit entities. To be considered a not-for-profit club, the club in question must be formally recognized by the Government of Saskatchewan or a similar body as a registered not-for-profit.
- 3. Eligible for Member Assistance Program Grant Funding (MAP): Officially registered not-for-profit Triathlon Saskatchewan recognized clubs are eligible for all MAP opportunities provided by the Triathlon Saskatchewan. Club sanctioned by Triathlon Saskatchewan but not recognized as not-for profit may be eligible for MAP Grant funding in special circumstances but generally are ineligible to receive MAP Grants. For-Profit clubs can apply for special grants and funding for good or services that will benefit the Triathlon Saskatchewan membership without any financial gain or advantage over any other club.
- 4. Clubs with a member or members under the age of 19 years must provide a criminal record check on behalf of their listed coaches every year.
- 5. All lead coaches and participants in Club training sessions must be current Triathlon Saskatchewan members.
